COVID-19 (novel coronavirus) update

Further to my letter dated 24 August 2020, as a valued member of the Sundale team, I wanted to provide you with an update and outline Sundale's current approach to managing the COVID-19 situation.

Sundale's Care Centre visitor restrictions at the below locations remain in place, despite no confirmed cases of COVID-19 at a Sundale Care Centre or Retirement Community:

- Bindaree Care Centre;
- Coolum Waters Care Centre;
- James Grimes Care Centre;
- McGowan Care Centre;
- Bowder Care Centre;
- Palmwoods Garden Village Care Centre;
- Rod Voller Care Centre (Rotary Garden Village).

The decision to restrict access at Sundale's Care Centres protects the health and wellbeing of our care recipients and team members and acknowledges Queensland Health's concerns a COVID-19 cluster linked to the Queensland Corrective Services Academy could be widespread.

Sundale will continue to review this decision.

Any healthcare worker or employee of an Aged Care service who has travelled to, or has had close contact with someone who has travelled to/from to the [below locations](#) must also notify their manager immediately.

Next steps, including whether you are allowed to return to work or enter any Sundale facility will be assessed on a case-by-case basis and could include a period of mandatory self-isolation.

Anyone who has been to the above-mentioned locations at these times should monitor their health and, if they develop even the mildest of COVID-19 symptoms, get tested immediately.

Care Centres

Sundale's Care Centres are closed to everyone except essential staff and health practitioners.

- Sundale Care Centres will not allow casual or non-essential access (which includes families, friends, school groups etc.);
- Visits from essential services such as GPs and allied health providers will continue;
- All internal lifestyle programs in each Care Centre have been bolstered to further support our care recipients.

From 1 May 2020, the Australian Government requires everyone who enters an aged care facility to have an up-to date seasonal flu vaccination.

Visitors will need to:

- Provide accurate details on their current health status to team members at Sundale's Care Centres;
- Be willing to undergo a screening process (including temperatures / previous travel);
- Reschedule their visit when feeling unwell.

If a visit is required by a family member with exceptional circumstances, Sundale will of course consider the request and it will be assessed on a case-by-case basis by the Site Manager, in partnership with the Executive Manager Aged Care and Community Services.

Palliative Care / End of Life

Sundale will ensure visits for family members in Palliative Care or for the purposes of end of life support including children under 16 years of age will occur.

Ongoing conditions

In line with their recommendations, visitors and team members should not enter a Sundale Care Centre if:

- They have been diagnosed with COVID-19 and have not finished their isolation;
- They returned to Queensland from overseas or interstate within the past 14 days;
- They have been in contact with someone who has had a confirmed case of COVID-19 within the past 14 days;
- They have been in a COVID-19 hotspot in the past 14 days; or have visited a Queensland COVID restricted area in the past 14 days;
- They have a fever or symptoms of a respiratory infection such as a cough, sore throat or shortness of breath.

Face masks

Sundale has also made the considered decision to provide reusable cloth face masks and/or single use surgical face masks to all Care Centre team members and visitors to help minimise the threat of COVID-19 entering a Sundale Care Centre.

Precautions outside of work

In line with recommendations from Queensland's Chief Health Officer, Dr Jeannette Young, I strongly encourage you to wear face masks in public if you cannot practice social distancing.

This advice acknowledges concerns a COVID-19 cluster linked to the Queensland Corrective Services Academy will grow this week.

Sundale will continue to work with Queensland Health and make responsible, considered decisions to protect the health and wellbeing of its care recipients and team members to help minimise the threat of COVID-19 entering a Sundale Care Centre.
